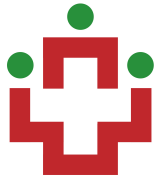

RELEASE, WAIVER AND INDEMNITY FORM

Release of Liability:

In signing this Release, Waiver and Indemnity form, I warrant that the child named above is capable of withstanding both the physical and mental demands of the activities. I also assume all risks of the child participating in the activities, whether such risks are known or unknown to me at the time. I further release Richmond Emmanuel Church (REC) and its rector, ministers, evangelists, coaches, leaders, employees, volunteers, council members and agents (Releasees) from any claim that my child may have or that I may have against them as a result of injury or illness incurred during the course of transportation or participation in activities. This release of liability shall include, without limitation, any claims of negligence or breach of warranty. This release of liability is also intended to cover all claims that members of the child's or my family or estate, heirs, representatives, or assigns may have against REC or its Releasees. I further agree to indemnify and hold harmless REC and its Releasees from any and all claims arising from my child's participation in its activities and programs, or as a result of injury or illness of my child during such activities.

Medical Release:

I hereby authorize the treatment for myself (in cases when accompanying my child), or the named child by a qualified and licensed medical doctor in the event of a medical emergency, which in the opinion of the attending physician, may endanger his/her life, cause disfigurement, physical impairment, or undue discomfort if delayed while participating in the activities including transportation to and from such activities. This medical release is granted only after a reasonable attempt has been made to contact the emergency contact person listed above.

Release of Transportation:

I also give my permission for myself (in cases when accompanying my child), or the named child to be transported in a church, rental or private vehicle or common carrier. I hereby voluntarily release any loss, damage, injury, illness, or actions, or causes of action for personal injury, property damage, wrongful or accidental death as a result of transfer, transport, or travel in a church, rental, private vehicle or common carrier.

Release of Personal Belongings:

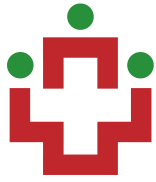

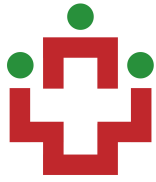
